- ***The nine school districts in St. Joseph County, with the support of the ISD, are offering a Section 105c Schools of Choice Program for 2nd Semester of 2011-12. This Program allows students of families who reside in Branch, Calhoun, Cass, Kalamazoo, or Van Buren Intermediate School District a choice to attend Burr Oak, Centreville, Colon, Constantine, Mendon, Nottawa, Sturgis, Three Rivers, or White Pigeon school district.***

- ***This booklet is designed to help families learn about the program and the policies and procedures that have been developed to help ensure student success.***

A family's checklist.....

1. Select your choice school (where you want your children to attend).

2. Submit your child's completed application to your choice school by:
12:00 noon on Friday, January 20, 2012
(Burr Oak, Colon, Constantine)
12:00 noon on Thursday, January 26, 2012
(Centreville)
12:00 noon on Friday, January 27, 2012
(Mendon, Nottawa, Sturgis, Three Rivers, White Pigeon)

3. Receive notification of acceptance or non-acceptance from your choice school after noon on January 20, 2012 (Burr Oak, Colon, Constantine) or after noon on January 26, 2012 (Centreville) or after noon on January 27, 2012 (Mendon, Nottawa, Sturgis, Three Rivers, White Pigeon).

4. Complete necessary enrollment forms at your choice school.

No person on the basis of race, color, national origin, gender, age, disability, religion, height, weight or marital status shall be discriminated against in our schools' programs, services and activities. Auxiliary aids and services are available upon request to individuals with disabilities.

What Families Need To Know

The Details for Applying for the Section 105c Schools of Choice Program

The application process for the Section 105c Schools of Choice Program has been designed to guarantee all applicants a fair and equitable opportunity for choosing a school. Families should be aware of the application timelines, length of transfers, and graduation requirements. Listed below are the guidelines regarding the application process:

1. Applications for the Section 105c Schools of Choice Program will be available at participating school districts during regular school hours. **The application must be returned to the choice school no later than:**
12:00 noon on Friday, January 20, 2012 (Burr Oak, Colon, Constantine)
12:00 noon on Thursday, January 26, 2012 (Centreville)
12:00 noon on Friday, January 27, 2012 (Mendon, Nottawa, Sturgis, Three Rivers, White Pigeon)
If a choice school receives an application after the deadline, the application will not be accepted. The family will need to apply for the Schools of Choice Program the next time it is open. If an application is late due to administrative error, the school will notify the ISD and the resident district and will process the application as if it had been received by the deadline.
2. A student is allowed to request which district he/she would like to attend, but requests for specific building(s) and/or teacher(s) will not be allowed.
3. A "Program Application" Form must be completed for each student (including siblings) wishing to participate in the Section 105c Schools of Choice Program. There are no guarantees of any siblings receiving admission into this Schools of Choice Program.
4. The number of transfers allowed under this Schools of Choice Program is determined by the space available in each participating district and the space available at each building. Local district boards of education may exceed this limit, at their discretion.
5. If the choice district receives more applications for the applicant's grade level than the choice district has space available, a "Random Draw System" will be held.
6. The choice district may refuse to enroll a non-resident applicant if the applicant is, or has been within the preceding two years, suspended from another school; if the applicant has ever been expelled from another school; or if the applicant has ever been convicted of a felony.
7. As required by Section 388.1705c(19) of the State School Aid Act – for Section 105c schools of choice students, in order for a district to enroll a nonresident pupil who is eligible for special education programs and services or who is a child with disabilities, the enrolling district shall have a written agreement with the resident district of the pupil for the purpose of providing the pupil with a free appropriate public education. The written agreement shall include, but is not limited to, an agreement on the responsibility for the payment of the added costs of special education programs and services for the pupil. The written agreement shall address how the agreement shall be amended in the event of significant changes in the costs or level of special education programs or services required by the pupil. A nonresident pupil who is eligible for special education programs and services or who is a child with disabilities cannot be enrolled in their choice school until this written agreement is in place.
8. Applicants will be notified as to whether they have been accepted into the program and if their choice school is available after noon on January 20, 2012 (Burr Oak, Colon, Constantine) OR after noon on January 26, 2012 (Centreville) OR after noon on January 27, 2012 (Mendon, Nottawa, Sturgis, Three Rivers, White Pigeon).
9. All transfers under this Schools of Choice Program take place by January 23, 2012 (Burr Oak, Colon, Constantine) OR by January 30, 2012 (Centreville, Mendon, Nottawa, Sturgis, Three Rivers, White Pigeon) OR immediately after the student is accepted (whichever comes later).
10. A student approved for transfer to a choice district is allowed to remain in the choice district until his/her class graduates from that school.

Graduation, Promotion, and Curriculum

Each school district in St. Joseph County ISD has developed a curriculum that is based on the State of Michigan Core Curriculum Model. In addition, each district has its own locally approved grading system and graduation requirements. While there are some similarities of requirements among districts, parents or guardians should be aware of the following conditions of the Section 105c Schools of Choice Program:

1. Students are required to graduate with the number of credits determined by the district they are attending at the time of graduation.
2. All districts will supply, at the request of parents or guardians, a current list of graduation requirements for the high school they wish to have their child attend. To receive a copy of graduation requirements, parents or guardians should contact the high school principal of the school of choice.
3. Upon acceptance into this Schools of Choice Program, a current listing of performance requirements from that building will be supplied to applicants.

Transportation Guidelines

Transportation is a key issue in the Schools of Choice Program. It is the sole responsibility of parents or guardians to transport their children to and from the choice school. The following is a list of the transportation guidelines for this Schools of Choice Program:

1. Parents or guardians will be responsible for transporting students to and from school in the Section 105c Schools of Choice Program. Parents or guardians should also be aware that on those rare occasions when school closes early due to weather, etc., it is also their responsibility to provide transportation for the child from the school to their home.
2. Parents or guardians may have the option to drive their child to a pre-approved bus stop in the school district of choice if space is available on the bus. Once the child is transported from school to the bus stop, it is the responsibility of the parents or guardians to provide transportation home for the child. Parents or guardians should also be aware that on those rare occasions when school closes early due to weather, etc., it is also their responsibility to provide transportation for the child from the bus stop to their home.
3. Parents or guardians will assume the responsibility for the safety of the child at the bus stop.
4. Students participating in the Section 105c Schools of Choice Program, who are eligible to ride a school bus, are required to follow the rules, regulations, and bus discipline policy of the choice district.
5. Section 105c Schools of Choice participants will be expected to arrive at the choice school on time every day.

Athletic Policy

The focus of this Schools of Choice Program is based on academics, not athletics. Therefore, students and parents or guardians should be aware of the following conditions for transferring:

1. Students will follow the choice district's policies for participation in the school's athletic activities.
2. A student athlete (junior high/middle school or high school) participating in the Section 105c Schools of Choice Program is eligible to participate in an inter-scholastic athletic contest according to the rules and regulations as defined and governed by the Michigan High School Athletic Association (MHSAA).
3. The action to include schools of choice within the St. Joseph County ISD does not affect the athletic eligibility of transferring students. Students who transfer by choice from one school district to another and do not otherwise satisfy the MHSAA transfer regulation are ineligible for inter-scholastic athletics for one full semester.
